Networking Opportunities

General Membership Meetings. The Membership meetings attract approximately 130 members. It is a great way to spend quality time and get to know your fellow Realtors in a casual atmosphere.

Pitch Plus is held every Friday morning (Oct. - May) in MIAAOR's Conference Center. This program gives Realtors the opportunity to pitch new listings, tour selected properties, and learn more about the Sponsoring Affiliate, who has 1 min. to talk about their business, as well as display and distribute marketing materials. Every week there are approximately 25-30 Realtor Members who participate in this program. Cost: \$75

Educational Classes are held throughout the year and offer Realtors an opportunity to earn required CE credits through accredited courses sponsored and supported by Affiliate membership. Affiliate members can sponsor sessions throughout the year. A calendar of sponsor dates is available through the Association. All sessions offer 3 minutes of floor time and distribution of marketing materials.

Social Events are held throughout the year. Affiliate members can choose to sponsor these events. They include Trade Show, and other local and civic events the Association chooses to participate in. Cost: Varies, dependent upon number of sponsors and agreed upon venue.

Annual Installation of Officers and Directors is an event held in December when the incoming MIAAOR officers and directors are installed, and awards are presented to Realtor of the Year, Rookie of the Year, Unsung Hero and Affiliate of the Year. Several Sponsorship Levels.

Lunch Hour Learning Sessions are held monthly discussing topics of interest. Affiliate Members have opportunities to speak. Seminars are scheduled by the Professional Development Committee.
